New approach on second-generation's Live Birth Late Registration

Registering a birth is important. Getting this document can be lifechanging. It is a process that takes time, so start today. It is worth the effort. It gives access to basic rights and services. And most importantly, it gives a feeling of being a whole person knowing you are accepted as you.

birth record is served to be the most crucial legal document in a person's life. It helps to establish one's rights. In addition to proving a person's identity, this document will also be utilized for education, employment, obtaining government benefits, and other purposes. It is the foundation for many legal papers and deals, and how you prove you belong. Despite this, still many Filipinos were unable to obtain it at this time. For this, late registration can be applied. Late registration occurs for a variety of circumstances including lack of awareness (some people don't know about the process), geographical distances (others live far from registration offices) financial constraints, some think it is not important, different cultural beliefs and home birth (common problem in remote areas where children born through traditional midwife or *hilot*). What more those children of Japanese descent born before and during World War II?

In the process of obtaining Japanese nationality for second-generation Japanese descent, birth certificate is one of the primary documents required by the Japanese family court. The crucial problem is most of the record in the civil registration offices before and during the war were destroyed due to the chaos during the war. Also, never forget, the anti-Japanese sentiments. Who would want to keep a record that could endanger their life? The reality is that there still number of secondgeneration lacks it.

This is why late registration is very necessary and important for 2nd generation Nikkeijin to prove their identity. The first Memorandum of Agreement between the Federation of Nikkeijin Kai and NSO, predecessor organization of PSA, was executed in 1995, where role of Regional Screening

Committee was prescribed. The MOA was updated in 2006, and then in August 2024, MOA between PNJK Rengokai and the PSA was signed by National Statistician and Civil Registrar General Claire Dennis S. Mapa, PhD and Dr. Ines P. Mallari, President of PNJK Rengokai.

urthermore, with the understanding and cooperation of both Japanese and Philippine government, on November 15, the PSA issued a Memorandum Circular No.2024-31: "Clarificatory Guidelines on Memorandum of Agreement between Nikkei Jin Kai Rengokai, Inc. for the Delayed Registration of Aging Second Generation of Filipino-Japanese Descendants", that has eliminated the mandatory requirement of 'Affidavit of Two Disinterested Persons" in the delayed registration of aging 2nd generation who are from the age of 80 and above. In lieu of the affidavit, the Regional Committee shall Screening (RSC) issue certification evaluation after the and assessment of the second-generation applicant signed by Chapter President as authorized representative of RSC. This certification serves as an important part of the supporting

document that must be provided to the Local Civil Registry offices. All other requirements by the LCR offices that are not affected by the guidelines will remain in effective. PSA vows to assist second-generation nikkeijin in acquiring late registration in the most efficient and timely manner possible. This agreement is one of the Philippine government's responses to the challenge of the second-generation in their twilight years.

/ / e hope that this motivates alive secondgeneration and their family not to lose hope. Seek assistance from Nikkeijin chapters for applying late registration. This birth registration initiative aims to recognize Filipino -Japanese descendants by the Philippines and Japan governments. This is the outcome of extensive discussion and negotiations with PSA, with the generous support of the Japanese Embassy. We express our gratitude to Minister and Consul General Takahiro Hanada for his contributions unwavering supports and regarding the late registration matters of second-generation. He is the driving force behind this discussion and we owe him a lot on this progress.

18th MOFA Interviews with Consul General

Consul General YOSHIHISA ISHIKAWA from Consulate-General of Japan in Davao City visited two stateless Filipino-Japanese War displaced descendants. Director Norihiro Inomata from Philippine Nikkei Jin Legal Support Center lead the visit of the two stateless members of Philippine Nikkei Jin Kai, Inc on February 28, 2025. The visit of Congen Ishikawa together with Mr. Inomata in identifying stateless will be of beneficial to the 2nd Generations who are appealing for recognition as child of Japanese in Court.

Julita Natsue Idemoto Tampos married to Sergio Tampos, residing in Upper Limonzo, Padada, Davao del Sur. She was separated from her father during the war when she was still an infant. Her father Jiro Idemoto came from Hiroshima Japan who got married to Natividad Alviola in Padada, Davao del Sur. During their union, they had 9 children and the youngest is Julita who has a Japanese name of Natsue. Jiro Idemoto children can speak Japanese, but they stopped using the language after the war for fear of persecution. When the war ended in 1945, Idemoto was repatriated to Japan. But he returned to Davao in December 1973 to look for his children. He was able to reached Padada by asking Filipinos about how to get to Padada, Davao del Sur, and eventually found the location. This is the first time the family has

reunited since the war, but he discovered that two of his children perished during the war.



2nd gen Nikkeijin to appeal in Japan

The Japanese government will invite the stateless 2nd generation from the Philippines is the answer of the Prime Minister Shigeru Ishiba when Councillor Ayaka Shiomura asked about the matters on the recognition of remaining 2nd generation nikkeijin in the Philippines in a parliamentary session on Mar. 5, 2025.

This year marks the 80th year anniversary of Prime Minister Shigeru Ishiba the end of World War II and there are still number of stateless child of Japanese that are yet to be recognized as Japanese citizen. It is timely to ask what the Japanese government has instore for the children of Japanese left behind in the Philippines because of the war.

Prime Minister answered that 'The children of Japanese immigrants in the Philippines



"have every right to travel to Japan and look for their relatives at the expense of Japanese citizens," and added, 'I am interested in meeting them to facilitate the dissemination of Japan's perspectives."

The Japanese government will assist them in gathering information to facilitate the process of obtaining Japanese citizenship. Additionally, it will organize meetings with Prime Minister Shigeru Ishiba.

The family celebrated the visit of Jiro Idemoto, and he even gave his wife Natividad a wedding ring as a gift. After the visit, Jiro went back to Japan again where he sadly passed away without his wife and children at his side. Julita Natsue knew from the time she was born that her father is a Japanese. However, she had no idea that she should acquire that nationality from her father. Only now that she understands the importance of her identity, not only for the good of herself but also for her children and grandchildren, who live in Japan.

Calvacion Nakagawa also known as Yuriko was born in Davao City on October 27, 1944. Her parents were Yoshitake Nakagawa and Concepcion Roel. Her father is from Hiroshima, Japan. He came to the Philippines before the war, met her mother, Concepcion Roel and got married. Salvacion is the youngest among 7 children of Yoshitake and Concepcion. During the war, her father left while she was still inside her mother's womb. Among the children of Yoshitake, only Salvacion was not registered in the kosekitohon, or family registry, because Yoshitake died during the war. Her elder sister Remedios and mother talked about


her father Yoshitake.

Salvacion now lives alone in her house in Toril, Davao City. All of her children and grandchildren currently living in Japan. At her age, her children are quite concerned about her current situation, as her health is not doing good due to her Alzheimer diseased. Her children wanted to bring her to Japan, so they applied Philippine Passport for her but was denied due to her status as child of Japanese. Because of her old age, the family were praying that her petition to become a Japanese would be decided as soon.

Both Julita Natsue and Salvacion Yuriko were impressed and very happy for being interviewed by ConGen Ishikawa in their house.







These include the 1,649 having successfully obtained Japanese nationality and 2,166 no Japanese nationality yet divided in the following categories: Alive, Deceased, and Status Unknown. The 134 confirmed Alive second generation are able to file for their nationality registration. Out of them, 50 interested, 21 undecided, and 63 Not interested. The 50 second-generation interested individuals are prioritized to help with petition filing: Baguio-2, Manila-10, Palawan-2, Cebu-6, Panay-4, Zamboanga-2, Davao-23, and Abroad-1. Since 2006, PNLSC has a total of 323 successful approved shuseki and currently, 6 ongoing shuseki cases.

Nikkeijin in Japan: Life Story



Initially alone, but with family soon...

My name is CRISTY SHIRAISHI AQUE, 55 years old. I am a 3rd generation Nikkei-jin, currently working here in Japan. My mother's name is Benita Shiraishi and she was born to a Japanese father named Shozo Shiraishi and a Filipino mother named Dionisia Fortaliza.

I have been working here for almost 15 years now. Currently, at bread factory in Hiroshima. I came here alone for the first time in November 2010. I was a little bit scared because I don't even know how to speak and understand Nihongo at that time. I told myself that I would only work here in Japan for two years only and I will be going back to the Philippines for good. But after two years, I had changed my mind. Despite the high cost of living in Japan, I used to love Japan because of its cleanliness and safety, and Japanese are very polite. In addition, I could see my cousins here, so I didn't feel lonely at all. I will just take a vacation in the Philippines and go back again in Japan to continue my work, which I've been doing for the past 14 years.

My Japanese grandfather, Shozo, came to the Philippines and worked as a carpenter in Pangasinan. I remember when I was 8 years old, my mother told us that her father was a Japanese. He was very friendly and had many friends. Some of his Japanese friends would always visit him at their house. She also told us that when they were young, my grandfather wanted to bring his family in Japan but my grandmother refused to go. Unfortunately, my grandfather was killed by guerrillas during the War. That's why they stayed in the Philippines. My mother was a dressmaker. She had her owned sewing machine in our house and accepted clients to sew their dresses. Until she passed away in 1987. And that was the hardest part for us, being her children, to lose a mother.

However, faith works differently. Although application of birth registration of my mother was once rejected in 2023 by the local civil registration section of Fukuyama city, appeal against that administrative decision was filed in the family court with assistance of Atty. Ohiwa and PNLSC, and won the favorable decision before the end of 2024. Finally my mother's name was registered in our grandfather's Koseki and she is now a Japanese national. I am very happy with that outcome because my daughter and siblings will be with me soon.
